### PHARMACY BENEFIT TRANSITION

Effective April 1, 2023, NYS Medicaid members enrolled in mainstream Medicaid Managed Care (MMC) Plans, Health and Recovery Plans (HARPs), and HIV-Special Needs Plans (SNPs) will receive their pharmacy benefits through the NYRx Pharmacy program instead of through their MMC Plan. The pharmacy benefit transition to NYRx does not apply to NYS Medicaid members enrolled in Managed Long-Term Care (MLTC) Plans [e.g., MLTC, Programs of All-Inclusive Care for the Elderly (PACE), Medicaid Advantage Plus (MAP), the Essential Plan, or Child Health Plus (CHP)]. Transitioning the pharmacy benefit from MMC to NYRx will provide NYS with full visibility into prescription drug costs, allow centralization of the benefit, leverage negotiation power, and provide a uniform list of covered drugs with standardized utilization management protocols simplifying and streamlining the drug benefit for NYS Medicaid members. NYS Medicaid consumers have comprehensive drug coverage and equitable access to an extensive network of over 5,000 pharmacy providers.

Providers, including prescribers, pharmacies and DMEPOS providers, **must be enrolled** in NYS Medicaid to receive reimbursement for services provided to Medicaid members. See [provider enrollment](#) for more information.

**Failure to enroll will result in denial of claims for prescriptions, effective April 1, 2023.**

## For Providers/Prescribers and Pharmacists

### NY Medicaid Pharmacy Program (NYRx) Information for Providers

Effective April 1, 2023, Medicaid members enrolled in mainstream Managed Care (MC) plans, Health and Recovery Plans (HARPs), and HIV-Special Needs Plan (SNPs) will receive their pharmacy benefits through the Medicaid Fee-for-Service (FFS) Pharmacy Program instead of through their Medicaid MC plan as they do now. The transition does not apply to members enrolled in Managed Long-Term Care plans (e.g., MLTC, PACE and MAP), the Essential Plan, or Child Health Plus (CHP).

Transitioning the pharmacy benefit from MC to FFS will provide the State with full visibility into prescription drug costs, allow centralization of the benefit, leverage negotiation power, and provide a single drug formulary with standardized utilization management protocols simplifying and streamlining the drug benefit for Medicaid members.

### What You Need to Know About Getting Your Prescription Drugs through Medicaid

Your pharmacy benefit is the part of your Medicaid health insurance that helps you pay for your prescription drugs and supplies. Before April 1, 2023, Medicaid members enrolled in a Medicaid Managed Care (MC) plan access their pharmacy benefit through their health plan. Medicaid members enrolled in Medicaid Fee for Service (FFS) access their pharmacy benefit through Medicaid Fee for Service. The Medicaid Fee for Service pharmacy benefit has been renamed NYRx, the Medicaid Pharmacy Program.

**Beginning April 1, 2023, all Mainstream MC Medicaid members will get their drugs through NYRx, the Medicaid Pharmacy Program.** This applies to consumers enrolled in MC plans, Health and Recovery Plans (HARPs) and HIV-Special Needs Plans (HIV-SNPs). Managed Long-Term Care plans (e.g., PACE, MAP, MLTC) and the Essential Plan are not included.

**For all Medicaid members affected by this change, our goal is to make this transition as seamless as possible by providing you the information and resources you may need in preparation for the move from your MC to NYRx.**

## Search for a Pharmacy or Medical Equipment Supplier

Find what you are looking for where you need it

Drugs and medical supplies may be available at a pharmacy. Additionally, medical supplies are available at a DME Supplier. Use the search tool to locate a pharmacy or DME supplier near you that takes Medicaid Fee for Service:

- Name (optional):** Provide at least the first three letters of the pharmacy or supplier's name. For example, enter "Wal" to search for pharmacies including Walgreens and Walmart
- Select Service:** Select the type of service location (Pharmacy, Medical Equipment Supplier & Dealer, or All)
- Select County OR Zip Code and Within:** Select either a county or enter a zip code and select a distance range within miles. The tool will search based on the distance from the zip code.

You may need to use the +/- buttons to see all results on the map. If you do not find the name of your pharmacy or supplier in the search results, try a broader search by leaving the name field blank. If you are searching by zip code, you may need to adjust the distance range.

**Please note the following:**

- Not all pharmacy names will be an exact match.** If the pharmacy name in the list is not an exact match, check if the address matches the pharmacy you are looking for.



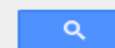
